In accordance with the provisions of Chapter 41, Section 81T and Section 81U of the Massachusetts General Laws, the Mansfield Subdivision Control Regulations and Zoning By-Law Section 230-5.6, Cluster Residential Special Permit, the Mansfield Planning Board will hold a public hearing on Wednesday, July 17, 2019 at 7:20 P.M. in Meeting Room 2A/B, Mansfield Town Hall, 6 Park Row, Mansfield, MA, regarding the application of Berlin Landing Realty Trust for the subdivision of a parcel of land located off of Gilbert Street and bounded as follows:

Gilbert Street, Verrochi, Millstein, Norige, Pierce, Quirk Realty Trust, Town of Mansfield, Woodside Realty Trust, Wayside Estates LLC, Pomerleau & Benson, Lacamera Realty Trust, Rapoza

The proposal is for the subdivision of Map 3, Parcels 9, 12, 13, shown on a plan titled "Sweetland Village" prepared by RIM Engineering Co., Inc., dated June 10, 2019, into five (5) new lots in the Industrial 1 (I1) and Residential 1 (R1) Zones.

In accordance with the provisions of Chapter 40, Section 15C of the Massachusetts General Laws and Chapter 20, Scenic Roads, of the Town of Mansfield General By-Laws, a scenic road public hearing will be held concurrently for alterations to be made to Gilbert Street, a scenic roadway.
