Sec. ____ . – No parking permitted.

No person shall park a vehicle at any time of any day on the streets or parts of streets designated in the following table.

Sec. ____ . – Parking time limited; four hours downtown.

No person shall park a vehicle for longer than four hours between the hours of 8:00 A.M. to 6:00 P.M of any day on the streets, parts of streets or Town-owned and operated lots designated in the following table. This restriction shall not apply on Sundays and State and Federal legal holidays.

This restriction shall not apply on Sundays and State and Federal legal holidays. Persons with a valid permit may park their vehicles in these areas at any time.
